



Dear Craft Exhibitor:

We cordially invite you to apply for admission to the Feast of the Flowering Moon Festival. This four-day event features Native American dancing and exhibits, Mountain men Rendezvous, historical re-enactments, free entertainment and top-quality crafts.

The dates for the festival are: **May 24-27, 2018**  
**Thursday 4:00 p.m. – 10:00 p.m.**  
**Friday 12:00 p.m. – 10:00 p.m.**  
**Saturday 10:00 a.m. – 10:00 p.m.**  
**Sunday 10:00 a.m. to 6:00 p.m.**

**\*\*Please note that this is a change of days from prior years\*\***

**A. SETUP/TEARDOWN:**

**Set up will be Thursday 24th 9:00 am to 2:00pm.** Teardown will be Sunday the 27th, after the Feast closes. Must be out of the park by 10:00 am Monday May 28th

**B. FEES:**

You will have one of the four choices for this year's set up.

1. Your **own** set up 10x10 - **\$150.00 includes electric**
2. Your **own** set up 20x10 - **\$300.00 includes electric**
3. Your **own** set up 30x10- **\$450.00 includes electric**
4. Your **own** set up 40x10 - **\$600.00 includes electric**

**C. General Information:**

1 - If you are a NEW vendor for 2018, you are required to submit a separate **money order** of \$100.00 as a deposit.

(Your \$100.00 deposit will be mailed to you the week after the festival, only if you stay the full weekend. If you leave early you will not be refunded the \$100.00.)

2 - Electric will be provided at the rear of each booth. Each hookup cannot exceed 20 amps.

**Each vendor should bring a 14/3 grounded extension cord and a plug in strip to accommodate your electric needs, and a 2018 tagged and updated fire extinguisher.**

3 - Vendors must provide their own cover at night. Security will be provided when festival is not in operation.

4 - There will be a \$50.00 penalty charged for applications not received by the deadline of **February 15, 2018**. This penalty will also be added if you just "show up" at the Feast without a reservation.

**D. REQUIREMENTS:**

- All items must be handmade by exhibitor to be located under "our tent".
- All crafts are subject to approval of the craft committee.

- All work must be original. No kit work (includes packaged needlework).
- No commercial or wholesale craft items accepted – If you are selling commercial, then you will need to fill out a commercial application.
- No glow necklaces or bracelets are to be sold. No shooters, poppers, or stink bombs are permitted.
- Photos of all items to be sold are required for *new crafters*. Photos will not be returned.
- Minimum 14/3 grounded electric cord 100 ft. long.
- 4 – 100 watt bulbs allowed per 10 ft. space. No floodlights or quartz lights permitted.
- Booths must be manned during all festival hours. **NO EARLY TEAR DOWNS OR YOU WILL FORFEIT YOUR DEPOSIT.**
- You are expected to keep your area free of trash and debris by cleaning your booth space.
- **No motor homes or vehicles are to be parked inside the festival area. (Please ask for parking information upon arrival.) – If you park in the area of the festival activities, you will be asked to move your vehicle!!**
- No mopeds, golf carts or pets allowed in festival area during festival hours.
- No generators permitted.
- Demonstrations are encouraged.

**APPLICATION DEADLINE:**

**Please return the contract by February 15, 2018**, along with BOTH checks or money orders made payable to: *The Feast of the Flowering Moon*. We will not be handling any monies at or during the festival.

**\*\*Please note: If your contract is not received by the deadline, your spot is not guaranteed. We reserve the right to limit the number of vendors selling similar items even if you are a returning vendor.**

Exhibitor agrees not to hold the Feast of the Flowering Moon, festival committee, the City of Chillicothe and County of Ross, responsible for any suits, damages, claims, loss or damage of property sustained while participating in the Feast of the Flowering Moon.

No floodlights or quartz lights allowed. **No motor homes or vans allowed in festival area.** Booth must be manned during all festival hours. No early tear down, or your deposit will NOT be returned. No mopeds, golf carts, or pets in festival area during festival hours. Be prepared to set up on pavement or grass. Cancellations must be made 14 days prior to Feast.
